    - 4. I kind of agree and disagree with Geno. This is not about later, it is about right now. I think there is no point to shoot the idea down right now. Krug
    - 5. I am not in favor of the Hidden Reggies Resolution.- Rubashkin
    - 6. I am very proud of Senator Marquis. The \$500 is worth it. I think it is a great tradition to start.- Mackey
    - 7. I agree with Geno, I think this is a cool idea. I still feel left to wonder if there are better options as opposed to just this one thing. If this is supposed to be a signature program, I feel like this could be lost.- McGinty

- 8. I disagree that this will disappear. The incoming people will have an idea to work with. –Thornton
- 9. I hear what Geno is saying, and I think that the big reveal will be a little too much.- Green
- 10. I agree with Senator Thornton. I think this is a good idea and it is ran well.- Volgman
- 11. I understand the idea of trying to make this bigger and getting financial support with co-sponsorship, but the Ad-Hoc Committee was just for a SGA program.- Spialek
- 12. I believe the big unveiling is just an idea. I support this 100%.Fettner
- 13. I have loved this since the beginning, but I would like to see another resolution because there is a great deal of money that can be used towards this.- McMahon
- 14. I would like to call to question- Larson
- iii. Resolution passes with 17 yays, 2 nays.
- g. Civic Engagement Committee Chair Election

    - 1. The person that Senator Owens kindly declined.-Mackey
    - 2. As a member of civic engagement, we would really like someone to be appointment. So I am for approval.- McGinty
    - 3. We do not have much time left in this association.- Hall

    - 5. I would not post-pone it.- Krug
    - 6. I feel like we should look more into it- Larson
    - 7. I would also encourage to post-pone it because the communication does not seem very clear.- Thornton
    - 8. It does not say anything in the by-laws. Scott contributes so much and has so many resources. I cannot think of a better person to fit this position. People are getting caught up in who in what position should hold this.- Colaric
    - There is only one inference to committee chairperson. The President of the Assembly is supposed to appoint a Senator.-Olshak
    - 10. I completely agree with any senator that wants to table this. I fully respect the decision. Based on what the other committee members said they are in favor of Secretary Preston. This was not some motive on the executive branch. Spialek
    - 11. I believe that we passed a bill saying that the Secretary of Governmental Relations that he is on that committee. Marquis
    - 12. As the legislation stands, it is interpreted it is. -Larson
    - 13. I think someone from the committee should set up.-Owens
    - 14. This is a matter of how the executive and legislative branch are separated.- Larson
