    - 3. We do not get a lot of visitors, and it is backwards logic to change the office before we even try to get more visitors.- Hall
    - When is this going to be done? There is no grunted when this will be done. I would feel more comfortable approving this money. – Mackey
    - 5. We need to be able to approve this as soon as possible so that it can be approved. I think we should have something that actually looks nice so people can visit and know that we are professional and here for them. In regards to moving to the Bone, there is not an inch of space for us to move into the Bone.- Fettner
    - They will have to add onto the Bone in order for us to move into it. It will not mess up our budget and the money is just sitting there. – Krug
    - I support the idea of moving the funds, I think what my concern is that Senator Marquis and Executive Director Krug makes the decision for the reconfiguration. I think everyone should have an opinion. – Fettner
    - 8. I accept this and we don't have the money. I was wondering if we could spend the money on more events instead. I agree with Ryan, and instead of changing the whole office.- Colaric
    - 9. I don't think the office is dysfunctional as it is.- Larson
    - 10. I like your idea Alana, and I think it would be a better idea. What Geno has said, too makes a good point. This will most likely take about 1-2 days to complete. The productivity will be higher because of the different format. Right now you can barely see what is behind the reception desk, with this reconfiguration people will be able to see into the office better.- Marquis
    - 11. I urge everyone to look at the big picture of this. I think space is an important productivity.- McGinty
    - 12. I call to question.- McGinty
    - 13. Objection.- Fettner
    - 14. I agree with Alana, but I also see the amount of money that would be used for this when it could be used elsewhere. \$10,000 will not bring us to the Bone. I am sure that we won't have \$90,000 ten

years down the line for us to move to the Bone. We might have to change the reception desk and maybe have someone sitting behind there.- Harris

- 15. I don't think that changing the office space will make us more productive. I am pretty sure that the administration knew that the money set aside was for the Bone as an investment. Hall

    - 4. It is also a goal for SGA to do at least one community service project for the semester. This would fulfill this. We are giving weeks in advance.- Green
