 - I am a little more confused on why we are going through this not through the fee route. It seems like it will be student fees and it will be structures that faculty can use. I am concerned on whether or not you will be able to advertise this fund enough. I am unsure about this and there is already a fee in University Housing. Students may be confused that they already pay a fee. I also don't know why this has been brought up so fast when we cannot talk to our constituents about this.- Hall
 - 2. This has to be approved through the students.- Olshak
 - 3. I am in support of this. By passing this, you are able to give the student body the ability to care. You are putting the decision in their hands. I think it would be inappropriate to add anything else to the info on the ballot.- Bagnuolo
 - 4. My only concern is that on-campus students will be paying twice. I understand it, but they will be paying more money. \$100,000 is a lot to start an initiative with.- Mackey
 - 5. We are extremely behind on sustainability practices on campus, so it is not a whole lot of money to be used.- Monahan
 - 6. It is not an arbitrary number, because it was calculated from the surveys. Considering other student fees, .34 cents is very low. I am pretty sure that the sustainability fee only goes towards the residence halls.- Krug
 - 7. This is something that Secretary Moore is doing to fulfill his bylaw duties. Last year this position was created and there is a line item that they will create a sustainability fee. There does need to be education for this and there is plenty of money in the forum

section. I completely agree with Student Trustee Bagnuolo, you can vote against it but this is putting the decision in the hands of students.- Spialek
