- 2. The SEC did felt that when senators run on a ticket system; it is not a fair or democratic way to elect people to SGA. People are elected based on who we know and whose ticket we appear on.- Carnahan
- 3. Do you think that senators having to run by themselves will prevent them financially?- Palmer
- 4. I believe that you would put as much money together when you are a part of a ticket. Financial limitations can hurt a candidates, but it will be the same as it is now.- Carnahan
- 5. Did you do other research on other schools?- Volgman
- 6. I did not, but presume that it is a norm.- Carnahan
- 7. I can account that it is a norm.- Olshak
- 8. Is it true that senators running can still campaign with other people without considering themselves a part of the party.- Preston
- 9. They would be allowed to donate, but not wholly contribute funds.- Carnahan
- 10. What would stop senators from running together with a top three?
- 11. They would not have the same name and their names would not appear on the same documentation.- Carnahan
- 12. This includes pictures? And there have been candidate information sessions...- Hall
- 13. This would not effect this year, it would effect next year.-Carnahan
- 14. If you are trying to do this for the next election, then why are we pushing this now instead of next years association?- Bagnuolo
- 15. I want to work on it.- Carnahan
- 16. You did not know about other schools and I feel like this is being rushed.- Bagnuolo
- 17. This is a more fair way to run SGA elections.- Carnahan
- 18. Can four friends get together and make a facebook group together to have them elected, or no?- Thornotn
- 19. No.- Carnahan
- 20. Theoretically, the SGA President picks all the senators, therefore they would vote that way.- Fettner
- 21. This is being handled right now.- Carnahan
- 22. This is being handled now to prevent a conflict of interest for next year.- Spialek
- 23. We also have to have a committee set up to approve this.- Mackey
- 24. Things start happening early for tickets, so we want to let them know now so they know in the future.- Krug
- 25. This is something that has been talked about for the past 2 years. We have been talking to past associations in SGA and we decided to do this for this year because of the amount of approval. – ARH
- 26. The code right now makes you allow to campaign electronically as long as it is not slanderous?- Mason
- 27. There is a new part of the code.- Mackey
- 28. I remember that we made sure that it wasn't attacking, but to clarify couldn't senators campaign together?- Mason

- 29. If an individual candidate wanted to make one to campaign to their friends, they would have to have it approved.- Mackey

- 31. No, we have not discussed it.- Carnahan
- d. Bill to Amend the Executive Branch By-Laws: Authorities, Powers and Responsibilities Secretary of Programming (Article 2, Section 3-D) (Larson)

 - 2. It says in the constitution that only senators can have voting rights.- Larson
- e. Bill to Amend the Executive Branch By-Laws: Authorities, Powers and Responsibilities Secretary of Governmental Relations (Article 2, Section 3-A) (Larson)
 - i. Questions:
 - 1. What purpose does it serve?- Preston
 - 2. This is so that secretaries can look in their own by-laws instead of following the legislative by-laws.- Larson
 - 3. There is nothing new in this that isn't already stated elsewhere?-Preston
 - 4. Correct.- Larson
- f. Bill to Amend the Legislative Branch By-Laws: Compensation (Article 2, Section 5) (Larson)
 - i. Questions:
 - 1. On lines 21 and 22, I am kind of inferring that being in the office and doing other duties are service and being in the meetings does not have us represent our student body. How are you making a delineation?- Mackey
 - 2. This is a collective RSO meeting, while the office hours are set.-Larson
 - 3. Point of clarification, isn't it a part of our job requirement?-Mackey
 - 4. Yes, but you would not be paid for the meetings.- Larson
 - 5. You said that the money be used to go back to RSO's through fee board? Are you saying that an RSO's program is serving the student body more than we are during our meetings?- Bagnuolo
 - 6. Yes, I feel that other RSO programs are more important.- Larson
 - 7. Is there a way that we can earmark the fees to go back to SGA?-Owens
 - 8. No.- Olshak
 - 9. Aren't we a department as well?- Fettner
 - 10. Yes, but meetings are an RSO activity.- Larson
 - 11. Why would you have not placed this on the agenda earlier in the year?- Fettner
 - 12. I did not think of it, but I am willing to make it affective for this association- Larson

- 13. Is this a conflict of interest if we are voting on ourselves?- Fettner
- 14. No, because we do not know who is serving next year.- Larson
- 15. Do you feel that this bill can turn away people from SGA because they will do well, but they need a job outside of SGA?- Mason
- 16. The bill requires that they would be in attendance that service in SGA is not necessarily a job. You are a service to your constituency.- Larson
- 17. What is the financial impact?- Moore
- 18. I have not considered that. It is enough money to make it worthwhile.- Larson
- 19. I do not see why the SGA meetings would be necessarily mandatory if they are not going to be paid for the three hours they serve. Why haven't you talked to me about the SGA meetings with the attendance by-laws?- McMahon
- 20. The SGA meetings should still be subject to the attendance bylaws.- Larson
- 21. We do not have control over where the money goes?- Volgman
- 22. This would go directly inot student fees. -Olshak
- 23. If you made this effective immediately, wouldn't it be a conflict of interest and wouldn't we all have to abstain?- Krug
- 24. I do not know of anyone in this room that says they want to cut their pay.- Larson
- 25. Members of congress vote on their pay. Voting on your pay is something that you are accountable to your constituents.- Olshak
- 26. There is no guarantee that this would go back to SGA?- Mackey
- 27. No.- Olshak
- 28. Being a part of SGA is a service and not a job, then why are we paid?- Rubashkin
- 29. We are a department and an RSO which makes us special. We would be paid for office hours and not the meetings. The meeting would be considered the RSO aspect and the rest of your office hours would be a service. –Larson
- 30. Do other members of academic senate paid?- Rubashkin
- 31. No.- Larson
- 32. To answer Secretary Moore's question, it was about \$10,000.-Owens
- 33. Is the RSO vs. Department opinion yours, or is it a generalize opinion?- McGinty
- 34. While I believe that is the opinion of Senator Larson, and this was brought up in the constitutional review commission. The constitutional commission posed this question.- Spialek
- 35. What does this mean? Is it the official opinion?- McGinty
- 36. I wanted to clarify that it is Senator Larson's opinion but also others from the constitutional commission.- Spialek
- 37. You said that office hours are apart of our job responsibility, but aren't the meetings as well?- Mason

- 38. It is, but it isn't. As an RSO on this campus, they do not get paid.-Larson
- 39. Point of Information- The Daily Vidette gets paid for their meetings.- Cahanin
- 40. Would this negatively effect the students?- BSU
- 41. No, because senators are still required to attend the meetings.-Larson
- 42. What is the difference of the meetings that ARH attends and that you attend on Wednesdays and are compensated for?- Bagnuolo
- 43. In our sense we are being paid to go to office hours and constituent contact events, and not paid to go to our meetings, which is different from ARH.- Larson
- 44. Have you really thought about this? What is the cost benefit analysis?- Fettner
- 45. I think the students would like to save their student fee dollars-Larson
- 46. This would not cut the hours they work.- Larson
- 47. Do you believe that the senators and other members go above and beyond and will it lower the notch?- Fettner
- 48. No, I do not believe it will lower the notch.- Larson
- 49. I move that we end Q and A- Mackey
- 50. Hochhauser seconds.
- 51. Mtoion passes with one nay.

 - c. I see what you are trying to do, but I will vote not because I think the committee chairs should appeal what they want to do to the entire association- Mason
 - d. I believe in the governing documents, they are considered a part of the executive team of the assembly. I feel that they should be elected by the assembly.- Larson
 - e. I have been a committee chair for two associations, but Point of Clarification, would this conflict the decision of the President of the Assembly from picking two people?-Preston
 - f. Yes, there would have to me more changes to the by-laws.-Olshak
 - g. I know that this was originated from the civic engagement committee, and the members were fine with the decision made. It does not change the tone or the purpose. If you are to elect someone before an entire assembly, isn't the executive branch interfering with this?- Spialek
 - h. I support this amendment. This would also mirror the Academic Senate committees.- Bagnuolo
 - i. The intention of this bill is for this entire assembly to vote on it.- Larson
 - j. What is the executive team?- Krug
 - k. It is a provision that is in the constitution, I have not convened them.- Carnahan
 - 1. What can they do?- Krug
 - m. I believe the purpose is to be conducive to my ideas. (joke)-Carnahan
 - n. I believe the exec branch should be involved, and the whole association should decide on this.- Mason
 - o. You would have ptoential conflicting bylaws.- Olshak
 - p. I disagree with this and hope that we will spark another bylaw change.- Mason

- b. Resolution Approving the Student Fee Budget for FY 2011 (Cahanin)
 - i. Move to approve, Owens second.
 - ii. Debate:
 - 1. A common thing that I noticed is that some people did not agree with the salary increase. I think people think that not now is the best time to get a raise.- Owens
 - 2. I have asked for your feedback. Do u have it?- Cahanin
 - 3. Yes, and only 4 people were okay with the salary increase.- Owens
 - 4. Did you describe what the Dean of Student Affairs staff do?-Fettner
 - 5. We should have written it, but we just simply state Student Affairs pay raise.- Owens
 - 6. Isn't that deceptive?- Fettner
 - 7. I was more open with my area government meetings, but if the questions were asked at the event, then I answered them.- Owens
 - 8. To be clear, the salary increase is for other areas on campus, such as athletics.- Olshak
 - 9. I would like to confirm what Senator Owens said, that a lot of people, while canvassing had contention for Student Affairs employee pay raises. The overall trend is people are against it, and I would recommend that people would like the SFKR building funded, but nothing else.- Larson
 - 10. We found similar information to what Senator Owens found, as well. Ruedig
 - 11. Though I might not agree with Senator Owens, I think it was uncalled for to say that he was deceptive to his constituents.-Volgman
 - 12. I understand the issue that students may have, I do not doubt for one second that Senator Owens did not present it objectively. I understand what Senator Larson said that they are not in favor of the other increase, but they may not know what Student Affairs do.- Spialek
 - 13. I think that it is hard for us to image how this affects us directly. It is to keep us competitive.- McGinty
 - 14. My line 28 says that it is a possibility of the pay increase. I think President Bowman is a compentent man to make the appropriate decision.- Mackey
