XI. Special Report

A. Historian/Archivist (J. Rubashkin)

- 1. At the start of the fall semester of 2010 the idea for creating the position of Historian/Archivist was formulated.
 - a. The reasoning behind this was to facilitate the research and understanding of decades of Student Government and their accomplishments.
 - b. It is hoped that this information once properly attained and cataloged can be put to good use for The Student Government Association and the Student Body at large.
- 2. Our first trip to the Archives was largely a preliminary investigation of possible materials. Though our original goals for this first visit were simple we were able to find a plethora of information on Student Government Association history from the previous 15 years.
 - a. A resolution suggesting the old meal plan be maintained and that the new version not be adopted
 - A constitution from 2000 that includes payment to be rendered to the president of the Student Government not in dollars but in student fees and tuition (though it should be noted at the time student fees and tuition were far lower so the overall pay of the president has likely not changed dramatically)
 - c. Ex-Officio groups such as NASA and the Graduate Students Association were a part of the Student Government Assembly
 - d. SGA internal surveys (This may be a good idea to revive as they were quite useful in ascertaining the vital knowledge and beliefs of Assembly Members)
- 3. On our second trip to the archives I was accompanied by both Secretary of Public Relations Robles and Senator Farrell.
 - a. A catalog of all SGA meetings from 1937-1944 was recovered and available for our viewing. This 400 page Tome will serve greatly in our endeavor to understand the mission of previous Student Governments, in this case Student Council, and their evolutions as well as their achievements.
 - b. This visit to the archives was a large morale boast as it was unclear if we would find any early documents on our earlier visit as well as the new potential of understanding that the sources found offer.
 - c. Findings include:
 - The 400 page tome of the student council from 1937-1944 (long lists of attendance were visible showing that senator groups were broken into freshman, sophomore, junior, senior, independent, and even a senator from the Vidette.
 - ii. Another small section was about the creation of a student contest where contestants would submit their entry by mail for a chance to win prizes of 5, 2, and 1 dollars. My priority for the spring will be to transcribe this document and make it available for all future Student Government Associations).
 - iii. Student made course catalogs

- 4. Our third and most recent trip to the Archives was held on November 18th shortly after the bill to adopt the position of Historian/Archivist was passed by the assembly
 - a. Archives Ross Griffiths, shortly before our visit, found within the old minutes of the Academic Senate the mention of a student council. Within this record of the Academic senate from the 1920s on there has clearly been a presence of students working for the good of the student body at ISU.
- 5. This final visit of the semester brought a wealth of information about student involvement at ISU and has given us a firmer resolve of transcribing all possible documentation about the hard work students have been doing at ISU for over 90 years.
 - a. Academic Senate Records 1920s- (some of the best minutes I have ever seen, and a model for us, that show one of the earliest forms of student government and student committees. Also seen within it were elections for the student council along with elections for the editor and co-editor of the Daily Vidette).
 - b. An additional student made course catalog
 - c. Academic Senate Records 1890s- (The legible script that we were able read include a vastly different and similar ISU. Professors had to nominate vote on Students for graduation at the time and whether formality or not it certainly does give insight into our university only 30 years after its creation).
- 6. Overall our three trips to the archives were very successful. We have found numerous documents from the past 15 years. With these in addition to the records at the office of Community Rights & Responsibilities we shall have a very well-rounded understanding of recent Student Government. The Tome of information from 1937 shall be transcribed as soon as possible and will help give insight into the student council of ISU from the depression and World War II. The Academic senate references to student council, student elections, and student committees will be useful in understanding the relevance and work students put into their home at ISU during the 1920s. Our three trips to the Archives have been an immense success. We will continue this work in the spring of 2011 when we intend to go to the archives twice a month.
