# Student Government Association Assembly Meeting April 14, 2010 7:36 PM- 9:55 PM

### **Call to Order**

- Meeting called to order by Student Body President Marquis at 7:36PM.

## **Executive Office Reports**

- Student Body President (D. Marquis)
  - We will be appointing six people tonight to various positions.
    - Three will be appointed to Senator positions, 3 will be appointed to Executive Staff positions.
  - o Later in the meeting will be elections for Officers of the Assembly.
  - o The Student Elections Code has become outdated recently.
    - He will be establishing an Elections Code Commission to review the current Elections Code.
      - It will have representatives from the Student Government Association, Association of Residence Halls, Black Student Union, and students at large.
    - We will be reviewing the Elections Code while it is still fresh in peoples' minds from the recent election.
    - More information will be coming.
    - People should let him know if they are interested in serving on the Commission.
  - There will be an attendance policy review taking place soon.
    - There are currently some holes in the existing policy.
    - The review will be done with himself, the President of the Assembly, the Vice President of the Assembly, Senator Mason, and Advisor Olshak.
    - The goal will be to make sure the attendance policy matches all of the By-Laws.
  - We may need to make some exceptions to the attendance policy for the next couple of meetings.
    - There are currently many Senators facing problems with having a Wednesday night class this semester.
  - There will be a resolution at the next meeting that deals with the Student Body Vice
     President and Student Body Executive Director.
    - The resolution will be to have both of them stay for several weeks over the summer.
    - The current By-Laws only require the Student Body Vice President to hold office hours over the summer.
    - President Marquis believes that it is also important to have the Student Body
       Executive Director hold office hours over the summer for several weeks.
    - The resolution will most likely have the Student Body Vice President split her summer office hours with the Student Body Executive Director.
    - This will eventually lead to a By-Laws change.
  - He is very excited for the start of this Association and is ready to get going on many initiatives.
  - He is very happy to have everyone in the Association, no matter how they got there.

- Student Body Vice President (L. Neely)
  - She apologizes for not being at the Transition Retreat.
    - She had some issues come up that needed to be taken care of.
  - She is starting to reorganize the Emerging Leader Program for next year.
    - Association members should begin thinking about if they would like to be mentors for an Emerging Leader member.
    - She will have more information about this at the summer meeting.
  - She will be contacting current members of external committees to see who would like to stay on those committees through next year.
    - People will have a chance to join any committee with an opening.
  - She is excited to meet everyone in the future.
- Student Body Executive Director (E. Bernacki)
  - People should talk to Susan Worrell if they have not done so yet.
    - People will not be allowed to swipe in for meetings and office hours until they talk to her.
  - People should meet with him after the meeting if they have not yet set up their Outlook accounts.
  - o If people have free time in their office hours, they should help to clean the office.
  - o He will have the mailboxes done in the office by tomorrow afternoon.
    - He is waiting to see the results of the Officers of the Assembly elections tonight so he can give people the right mailboxes.
  - Association members should send him their office hours for the rest of this school year by 5pm on Friday, April 17.
    - Senators need to have three office hours.
  - o Questions
    - Senator Cotter says she is still having issues swiping in.
      - Executive Director Bernacki will look into this issue.
    - Senator Farrell wants to know where people can swipe in.
      - President Marquis says there are two places to swipe in- outside the Student Government Association office by the vending machines and in the Bone Student Center next to the University Program Board.

## **Advisor Report (R. Olshak)**

- 1) Payroll Issues- he will be working with Susan Worrell to implement a new payroll system which will be in place by the summer Assembly Meeting.
  - a. The current system is no longer in compliance with University procedures and presents significant operational difficulties for the business office.
  - b. Presently, rates vary by position based on the idea that they are stipend positions.
    - i. The business office can no longer view Association members as student receiving stipends.
    - ii. Instead people will be viewed as receiving an hourly wage.
    - iii. The rate will be re-set for everyone in the Student Government Association is receiving the same hourly rate and that pay differential will be based solely on hours worked.
  - c. The overall pay is capped by the amount of salary money included in the pool approved through the Fee Review process.

- i. They will work backward from the overall amount based on the maximum number of hours that can be worked according to the Student Government Association By-Laws.
- d. More information will be provided once the new system is in place.
  - People should be aware that the check they receive at the end of this month may or may not be indicative of the amount they will be receiving next fall and spring.
  - ii. He does not expect there to be a significant difference in anyone's pay.
- 2) He will be out of town at the next business meeting on April 28.
  - a. Michael Zajac, the Coordinator of Off-Campus, Nontraditional, and Parents' Services, will be taking his place for the night.
  - b. People should be respectful to him.
  - c. This will be a good opportunity for members to get to know Zajac because off-campus issues will be a defining piece of the 2010-2011 Administration.
- 3) Anyone running for Office of the Assembly positions tonight should know that Executive Committee meetings are held every Monday at 5pm in the Dean of Students Office Administrative Conference Room.
  - a. This is a requirement for all office positions.
  - b. Short Executive Committee meetings are also held after every Assembly Meeting.
- 4) He thanks everyone who has met with him so far this week, and he knows he still has several more people to meet this week.
  - a. People should remember to complete their personnel paperwork if they have not done so already.
  - b. People are now able to get paid, and the only way they can get paid is if they are active in the payroll system.
    - i. There will be no back pay.

    - They have paid over \$40 million so far.

    - He will still be the Student Trustee at that meeting because his term ends at the end of the fiscal year.
  - He is going to make an effort to be in the office over the next several weeks.

    - ARH asks if the sustainability fee referendum will be voted on at the May 7 Board of Trustee meeting.
      - Trustee Bagnuolo is not sure which meeting it will be voted on because the University is still trying to work out the details.
    - Trustee Bagnuolo says that many Universities throughout the state are raising tuition and Illinois State University is in a good place currently.

  - e. Senator Mason calls for unanimous consent.

  - g. Secretaries Anderson, Colaric, and Olson take the oath of office.

    - iii. Each nominee will have five minutes to give a speech.
      - 1. The nominee will then take questions and answers.
    - iv. Then the next nominee will come into the room and begin the process over.
