3 Bill for the addition of a section to the Executive and Legislative By-Laws concerning the Executive
4 Committee

6 WHEREAS, the Student Government Association is the official student governing body for Illinois State
7 University;

8
9 WHEREAS, there is currently no section within the legislative or executive By-Laws concerning the
10 executive committee;

11
12 WHEREAS, the governing documents of the Student Government Association need to be as clear and
13 transparent as possible;

14
15 WHEREAS, the by-laws are intended to be amended and improved over time;

16
17 WHEREAS, including a section within both the executive and legislative by-laws would be beneficial, to
18 the understanding, of those reading governing documents in the future;

19
20 WHEREAS, the Policies and Procedures Committee has the responsibility within the Legislative ByLaws
21 article 3 section 2 D. iii. To recommend changes in SGA governing documents to the Assembly;

23 THEREFORE, BE IT RESOLVED, That the Executive By-Laws and Legislative By-Laws be kept as up
24 to date and as clear as possible concerning the internal Student Government Association process and
25 practices;

27 BE IT FURTHER RESOLVED, That Legislative By-Laws Article 7 and Executive By-laws Article
28 8 be added as follows

29
30 “Executive Committee
31 A. Membership
32 The Memberships of the Executive Committee shall include the President of the Assembly, Vice
33 President of the Assembly, Secretary of the Assembly, President of the Student Body, Vice
34 President of the Student body, Executive Director, and the Advisor serving as an ex-officio.

35
36 B. Open Meetings
37 All meetings of the Executive Board shall be open to the public in accordance with the Illinois
38 Open Meetings Act. The Board may enter executive session in regards to matters of discipline,
39 performance, or dismissal of specific employees.

40
41 C. Authorities, Powers, and Responsibilities
42 i. To set the agenda for General Assembly meetings.
43 ii. To review personnel issues
44 iii. To set the agenda for caucus in conjunction with the President of the Assembly.
45 iv. May require attendance with a minimum of two (2) weeks notice given to the entire assembly.
46 v. May approve speaking privileges for persons addressing the Assembly.
47 vi. To Serve as the Official Appeals Board for the Student Fee Board.”
