4 *Bill to Amend the Executive Branch By-Laws: Authorities, Powers, and Responsibilities (Article 1,*  
5 *Section 2)*

7 WHEREAS, the Student Government Association (SGA) is the official student governing body for  
8 Illinois State University;

9  
10 WHEREAS, improving communication and productivity are goals of the 2010-2011 Student Government  
11 Association Administration;

12  
13 WHEREAS, the Executive By-Laws are the governing documents for the Executive Branch;

14  
15 WHEREAS, authorities powers and responsibilities can be found in Article 1, Section 2 of the Executive  
16 Branch By-Laws;

18 WHEREAS, having both the Vice-President and the Executive Director of the Student Body available  
19 over the summer in the Bloomington-Normal community allow for more productivity;

20  
21 WHEREAS, currently only the Vice-President is mandated to stay in the community for 45 days;

22  
23 WHEREAS, this past summer the assembly allowed for the payment of Vice-President and the Executive  
24 Director while in the Bloomington Normal community for up to twenty-three (23) days and proved  
25 successful;

27 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association along with the  
28 constituents of Illinois State University, accept the bill authorizing the amendments to the Executive  
29 Branch By-Laws (Article 1, Section 2);

30  
31 BE IT FURTHER RESOLOVED, Article 1, Section 2B, line ix of the Executive Branch By-Laws shall  
32 be amended to read “ix. To be in attendance in the community of Bloomington/Normal for at least  
33 twenty-three (23) days during the summer. In this time, he/she shall keep regular office hours in  
34 order to serve the University Community”;

35  
36 BE IT FURTHER RESOLVED, Article 1, Section 2C, line xvi of the Executive Branch By-Laws shall be  
37 added to read “xvi. To be in attendance in the community of Bloomington/Normal for at least  
38 twenty-three (23) days during the summer. In this time, he/she shall keep regular office hours in  
39 order to serve the University Community” with all subsequent points being moved down a  
40 numeral;

42 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the  
43 Secretary of the Assembly and the SGA Advisor to make all necessary changes to the Legislative Branch  
44 By-Laws;

46 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the  
47 Secretary of Information Technology to make all necessary changes to the SGA Web site.
