

1 2 3 Sponsor: Senator Farrell, Senator Rubashkin, Senator Boldt, Senator Tomlin, Senator Gentile, Senator Vacura Bill for the RSO Senators Committee Assignment 4 5 WHEREAS, the Student Government Association is the official student governing body for Illinois State 6 University; 7 8 WHEREAS, RSO Senators key role is representing registered student organizations and their needs; 9 10 WHEREAS, Finance and Allocation Committee has five SGA senators on the Program Fund Board; 11 12 WHEREAS, the purpose of the Program Fund Board is to allocate funds to RSOs though out the year for 13 programs and events; 14 15 WHEREAS, RSO senators would best represent their constituents by sitting on this board that distributes 16 annually approximately \$210,000; 17 18 WHEREAS, sitting on this board would give RSO senators the best insight at the process and would be 19 able to best assist RSOs in applying for the fund if sitting on the board; 20 21 THEREFORE, BE IT RESOLVED, the wording for RSO senators responsibility will state in the 22 legislative bylaws in: 23 Article 2. Membership 24 25 Section 1. Assembly Apportionment 26 27 Sub-section A. 28 29 Point V. Two (2) Registered Student Organization (RSO) Senator elected by a plurality of the 30 student body shall serve to represent the interests of Registered Student Organizations. RSO 31 Senators shall work to reach out to registered student organizations through the Dean of Students Office, Student Involvement Center. The RSO Senators will be responsible for 32 33 administering the RSO of the Month program. They shall also be appointed to the Finance and Allocation Committee unless: the senator holds an officer of the assembly position, in 34 35 this case they will be exempt from this committee, or if the committee is already full, 36 current members do not need to leave, but if openings exist then the RSO senators must 37 ioin the committee if already not assigned a committee. 38 39 BE IT FURTHER RESOLVED, the responsibility of assigning the RSO Senators will fall to the President 40 of the Assembly, with the Chair of Policies and Procedures overseeing the appointments to ensure the 41 continuation of this policy; 42 43 BE IT FURTHER RESOLVED, This policy will take effect after the elections for the SGA 2011-2012 44 administration. 45 46 47 Adopted by the Assembly of the Student Government Association on the __9th _ day of ___February___ 48 2011. 49
