3 Bill to amend the SGA External Committee, Student Sustainability Committee

4
5 WHEREAS, the Student Government Association is the official student governing body for Illinois State
6 University;

7
8 WHEREAS, sustainability is one of the 2009-2010 Student Government Association goals;

9
10 WHEREAS, increasing faculty participation on the Student Sustainability Committee (SSC);

11
12 WHEREAS, the new language will be added to II. Membership C. Faculty and Staff Non-Voting and
13 read;

14
15 *“2. The Student Sustainability Committee will have a minimum of three faculty advisers and a*
16 *maximum of 8. The Student Sustainability Committee must have faculty advisers representing a minimum*
17 *of three of the following colleges; College of Applied Science and Technology, College of Arts and*
18 *Sciences, College of Business, College of Education, College of Fine Arts, Mennonite College of Nursing.*

19
20 *The role of faculty advisers will be to provide committee oversight. Faculty advisers will not have voting*
21 *rights, but their participation and input shall be taken into account*

22
23 *Faculty advisers will be appointed by the Secretary of Sustainability and their appointment will be voted on*
24 *by the Student Sustainability Committee. Majority vote is needed to approve appointment.*

25
26 WHEREAS, there will be an amendment to term(s) served;

27
28 WHEREAS, the new language for term(s) served will read;

29
30 *“1. Students and SGA members serving on the committee will have their services terminated with the*
31 *change of SGA in spring semester. If there are events planned that take place after the change of SGA in*
32 *spring semester then members will serve in a limited capacity until the event is complete. Their activities*
33 *shall not be canceled by the incoming administration and they shall not interfere with the incoming*
34 *administration.*

35
36 *2. Faculty members serving on the committee will be limited to continuous service four years at*
37 *which time they would need to be reappointed to their position. If they should resign prior to the four*
38 *continuous years then another faculty advisor would need to appointed to the open position.”*

39 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association authorizes the
40 amendment of SGA’s External Sustainability Committee, the Student Sustainability Committee (SSC).
