 3 *Bill to Establish an Official SGA Alumni Newsletter and Amend the Executive Branch By-Laws:*  
 4 *Executive Cabinet Members Authorities, Powers and Responsibilities (Article 2, Section 3B)*  
 5  
 6 WHEREAS, the Student Government Association is the official student governing body for Illinois State  
 7 University;  
 8  
 9 WHEREAS, the Executive Branch By-Laws are the governing documents for the Executive Branch;  
 10  
 11 WHEREAS, Authorities, Powers and Responsibilities for the Secretary of Public Relations can be found  
 12 in Article 2, Section 3-B of the Executive Branch By-Laws;  
 13  
 14 WHEREAS, Communication is one of the main initiatives of the 2009-2010 Student Government  
 15 Association;  
 16  
 17 WHEREAS, there is no form of communication between the current Student Government Association  
 18 and their alumni;  
 19  
 20 WHEREAS, a solid alumni relationship can bring valuable resources and feedback to the Student  
 21 Government Association;  
 22  
 23 WHEREAS, an alumni newsletter would increase communication between alumni and the Student  
 24 Government Association;  
 25  
 26 WHEREAS, past associations have distributed an alumni newsletter in the hopes of it becoming a  
 27 permanent part of the Student Government Association;  
 28  
 29 WHEREAS, the Secretary of Public Relations will be assigned to distribute an alumni newsletter once a  
 30 semester;  
 31  
 32 WHEREAS, the content of the alumni newsletter will be at the discretion of the Secretary of Public  
 33 Relations and the Executive Committee;  
 34  
 35 WHEREAS, the Secretary of Public Relations must submit a funding request and/or resolution before it is  
 36 sent to alumni;  
 37  
 38 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association along with the  
 39 constituents of Illinois State University, accept the bill authorizing the amendment to the Executive  
 40 Branch By-Laws (Article 2, Section 3-B);  
 41  
 42 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association along with the  
 43 constituents of Illinois State University accept the bill authorizing the creation of a *SGA Alumni*  
 44 *Newsletter* that will be distributed once a semester;  
 45  
 46 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the  
 47 Secretary of the Assembly to make all necessary changes to the Executive Branch By-Laws.

 49 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the  
 50 Secretary of Information Technology to make all necessary changes to the SGA Web site.
