 3 *Bill to Amend the Legislative Branch By-Laws: Compensation (Article 2, Section 5)*  
 4  
 5 WHEREAS, the Student Government Association is the official student governing body for Illinois State  
 6 University;  
 7  
 8 WHEREAS, the Legislative Branch By-Laws is the governing document for the Legislative Branch;  
 9  
 10 WHEREAS, Compensation can be found in Article 2, Section 5 of the Legislative Branch By-Laws;  
 11  
 12 WHEREAS, the Student Government Association is an RSO of Illinois State University;  
 13  
 14 WHEREAS, service in Student Government is a privilege and a service to the students of Illinois State  
 15 University;  
 16  
 17 WHEREAS, to provide an enhanced commitment to serve the student body and to better allocate Student  
 18 Fee Dollars;  
 19  
 20 WHEREAS, Student Government Association Senators shall only be paid for hours of work completed in  
 21 the SGA office and in other duties that are deemed to be in service to the student body;  
 22  
 23 WHEREAS, Student Government Association Assembly meetings and Academic Senate meetings shall  
 24 not count towards payment of Senators;  
 25  
 26 WHEREAS, Assembly Senators shall serve 5 paid hours in service to the student body per week;  
 27  
 28 WHEREAS, Assembly Officers shall serve 11 paid hours in service to the student body per week;  
 29  
 30 WHEREAS, this amendment will take effect with the 2010-2011 Student Government Association  
 31 Administration;  
 32  
 33 WHEREAS, attendance at Student Government Association Assembly meetings and Academic Senate  
 34 meetings shall be subject to the Legislative Branch By-Laws Article 6, Section 2;  
 35  
 36 WHEREAS, stipends shall be adjusted by the Dean of Students Business Office according to the number  
 37 of hours worked in a week for Senators and Assembly Officers;  
 38  
 39 WHEREAS, excess funding shall be forfeited to the Student Fees process for reallocation;  
 40  
 41 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association along with  
 42 constituents of Illinois State University, accept the bill authorizing the amendment to the Legislative  
 43 Branch By-Laws;  
 44  
 45 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the  
 46 Secretary of the Assembly to make all necessary changes to the Legislative Branch By-Laws.  
 47  
 48 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the  
 49 Secretary of Information Technology to make all the necessary changes to the SGA web site.
