6 WHEREAS, the Student Government Association is the official student governing body for Illinois State  
 7 University;

 9 WHEREAS, sustainability is a goal of the 2008-2009 Student Government Association Administration;

 11 WHEREAS, the Off-Campus Recycling event will take place Saturday, October 25, 2008 at 11:30 to 1:30  
 12 pm in the Hancock Stadium parking lot;

 14 WHEREAS, on Saturday, October 25, 2008 the ISU football team will be playing North Dakota State at  
 15 Hancock Stadium;

 17 WHEREAS, many constituents will be present at this location;

18  
 19 WHEREAS, the Off-Campus Senators of the Student Government Association have planned an  
 20 educational and constituent feedback event for the purpose of Off-Campus recycling concerns;

 22 WHEREAS, off-campus recycling is an integral part of creating a more sustainable campus;

 24 WHEREAS, \$433.00 has been allocated and approved by the Finance and Allocation Committee for this  
 25 event;

 27 WHEREAS, 1,000 people are anticipated to attend the event, and 850 being students;

 29 WHEREAS, the Student Government Association will hand out off-campus recycling surveys and other  
 30 educational literature in order to analyze the relationship with students and off-campus recycling;

 32 WHEREAS, it is mandatory for all Off-Campus Senators of the Student Government Association to  
 33 attend this event for one hour each and highly recommended for the rest of the Assembly;

 35 WHEREAS, Vice President of the Assembly Krug will be responsible for placing this event in the  
 36 constituent email;

 38 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association authorizes  
 39 participation in the Off-Campus Recycling Event;

 41 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the Student  
 42 Body Executive Director to work with the Off-Campus Senators and Advisor Olshak to ensure that all  
 43 appropriated funds are allocated and the logistical arrangements are made accordingly.
