Resolution Authorizing Ewing Manor Event 2 3 WHEREAS, the Student Government Association is the official student governing body for Illinois State 4 University; 5 6 WHEREAS, the participation in public engagement opportunities is a goal of the 2007-2008 Student 7 Government Association Administration; 8 9 WHEREAS, the Executive Officers would like to provide the Student Government Association and 10 Emerging Leader Program Participants with an opportunity to engage with university, town, and 11 governmental officials through the sponsorship of a "Mix and Mingle with the Administration at Ewing 12 Manor" event; 13 14 WHEREAS, this event would give the Association and participants an opportunity to meet face-to-face 15 with many university, town, and governmental officials and be able to understand their role with Illinois 16 State University; 17 18 WHEREAS, the event would be held on Sunday, October 21, 2007, and attendance is mandatory for all 19 Association members including both the legislative and executive branch; 20 21 WHEREAS, the Assembly of the Student Government Association must approve the SGA Operational 22 Budget each fiscal year and did so on September 5, 2007; 23 24 WHEREAS, the SGA Operational Budget and ELP Operational Budget both had line items for this event 25 which was approved at the Assembly meeting on September 5, 2007; 26 27 WHEREAS, the Emerging Leader Program will contribute \$500.00 and the SGA Operational Budget will 28 contribute \$500 from the line item in the Operational Budget to the "Mix and Mingle with the 29 Administration at Ewing Manor" event; 30 31 WHEREAS, the total event cost would be to cover cost for food, rental, decorations, invitations, and other 32 miscellaneous supplies; 33 34 WHEREAS, the Student Body President would be responsible for overseeing all invitations sent to 35 university, town, and governmental officials, preparing the final guest list, set-up and clean-up of the 36 event, and any other things needed discussed during Executive Officer Meeting; 37 38 WHEREAS, the Student Body Vice President would be responsible for overseeing all of Emerging 39 Leader Program participants attendance, logistical arrangements for food, set-up and clean-up of the 40 event, and any other things needed discussed during Executive Officer Meeting, 41 42 WHEREAS, the Student Body Chief of Staff would be responsible for overseeing the creation of the 43 invitation to be sent out one month in advance, decorations, logistical arrangements of Ewing Manor, set-44 up and clean-up of the event, and any other things needed discussed during Executive Officer Meeting, 45 46 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association directs the 47 Executive Officers to give an update of the event the Assembly meeting prior to the event to ensure the 48 Assembly is completely informed of the arrangements. 49
