17 over the sum of \$500;

19 WHEREAS, \$1000 is to be used on Student Government Association sponsored events and co-

22 WHEREAS, giving \$500 will provide the Student Government Association with the opportunity and
23 recognition of co-sponsorship of Homecoming Feature Friday;

25 WHEREAS, giving \$500 will be used to pay for the rights to play the film;

27 THEREFORE, BE IT RESOLVED, the Student Government Association authorizes the Co-Sponsorship
28 of Homecoming Feature Friday;

30 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association accepts the
31 recommendation of the Finance and Allocation Committee and approves a \$500 allocation for the funding
32 request for the Co-Sponsorship with the University Program Board for Homecoming Feature Friday;

34 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the Student
35 Body Executive to work with Advisor Olshak to ensure that all appropriate funds are allocated and that all
36 logistical arrangements are made accordingly;

38 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Secretary
39 of Programming Colaric to work with the Secretary of the Assembly Diaz to transmit signatures copies of
40 this resolution to the University Program Board.
