*Resolution Establishing the Campus Dining Services Retail Operations Advisory Committee*

WHEREAS, the Student Government Association is the official student governing body for Illinois State University;

WHEREAS, it is a goal of the 2011-2012 Student Government administration to increase student advocacy so that student perspectives are considered at all levels of University decision-making;

WHEREAS, there is currently no advisory committee in place to address campus retail dining operations and their function within the campus community;

WHEREAS, the review of off-campus student meal plan options, plan components, and pricing is completed through a process with no off-campus student input;

WHEREAS, the 2011-2012 Student Government administration has worked with the Division of Student Affairs to address these issues;

WHEREAS, a Retail Operations and Off-Campus Meal Plan Advisory Council has been proposed by the Division of Student Affairs;

WHEREAS, the Vice President of Student Affairs office and the 2011-2012 Student Government administration recommend the establishment of such a council that will evaluate campus community food venue interests and make recommendations, and review the off campus meal plan rates;

WHEREAS, additional responsibilities and duties of the Campus Dining Services Retail Operations and Off Campus Meal Plan Advisory Council are outlined in detail in the attachment accompanying the resolution;

THEREFORE, BE IT RESOLVED the Assembly of the Student Government Association supports the establishment of the Campus Dining Services Retail Operations and Off Campus Meal Plan Advisory Council;

BE IT FURTHER RESOLVED, the Council shall be composed of five student members, and three faculty/staff members, with the Director of Campus Dining Services serving as the chair;

BE IT FURTHER RESOLVED, The Student Body Vice President, with the approval of the SGA Executive Committee, shall appoint five students to serve on the board;

BE IT FURTHER RESOLVED, that the Council shall meet at a minimum twice a semester;

BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Secretary of the Assembly Collins to transmit a copy of this resolution and the accompanying attachment to the Office of the Vice President for Student Affairs;

BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Vice President of the Assembly McMahon to communicate the content of this resolution and the



49 accompanying attachment to all students in the constituent contact e-mail immediately following passage
