4 *Resolution Establishing the Mandatory Student Fee Review Board*

6 WHEREAS, the Student Government Association is the official student governing body for Illinois State  
7 University;

8

9 WHEREAS, the 2011-2012 Student Government administration is committed to a transparent  
10 Association that focuses on the preservation of students rights;

11

12 WHEREAS, it is the responsibility of the Student Government Association to manage the student fee  
13 review process;

14

15 WHEREAS, the 2011-2012 administration was concerned by the absence of a student fee review process  
16 last year for the 2012 fiscal year;

17

18 WHEREAS, Student Body President Owens worked with the Vice President of Student Affairs office to  
19 ensure that the input and feedback of students would be guaranteed when the student fee recommendation  
20 for fiscal year 2013 is formulated;

21

22 WHEREAS, the Vice President of Student Affairs office and the 2011-2012 Student Government  
23 administration recommend the establishment of the Mandatory Student Fee Review Board that will  
24 provide student input on mandatory student fees, increase student awareness of divisional budgetary  
25 priorities, and educate the SGA on the restrictions, uses, and overall process for settling and allocating  
26 student fees for the various entities within the Division of Student Affairs;

28 WHEREAS, additional responsibilities and duties of the Mandatory Student Fee Review Board are  
29 outlined in detail in the attachment accompanying the resolution;

30

31 THEREFORE, BE IT RESOLVED the Assembly of the Student Government Association supports the  
32 establishment of the Mandatory Student Fee Review Board;

33

34 BE IT FURTHER RESOLVED, the Mandatory Student Fee Review Board shall be composed of six  
35 student members, with the Secretary of College Affordability serving as the chair;

36

37 BE IT FURTHER RESOLVED, The Student Body Vice President, with the approval of the SGA  
38 Executive Committee, shall appoint five students to serve on the board;

39

40 BE IT FURTHER RESOLVED, that the Mandatory Student Fee Review Board shall meet at a minimum  
41 every other week in the fall and into the early spring;

42

43 BE IT FURTHER RESOLVED, that the members of the Mandatory Student Fee Review Board shall  
44 make a presentation to the Student Senate in February on student fee rates for the following year;

46 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Secretary  
47 of the Assembly Collins to transmit a copy of this resolution and the accompanying attachment to the  
48 Office of the Vice President for Student Affairs;

50 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Vice  
51 President of the Assembly McMahon to communicate the content of this resolution and the



52 accompanying attachment to all students in the constituent contact e-mail immediately following passage  
53 of this resolution.
