Sponsors: President of the Assembly Larson, Vice President of the Assembly Collins, Secretary of the Assembly Collins, Student Body President Owens, Student Body Vice President Von Qualen, Executive **Director Davis** Resolution Establishing the Legislative Policy and Research Ad Hoc Committee WHEREAS, the Student Government Association is the official student governing body for Illinois State University: WHEREAS, to further represent the diverse view point of ISU's Student Body the creation of an Ad Hoc Committee to address legislative priorities and goals is needed to promote legislative action by the Student Government Association; WHEREAS, through the promotion and discussion of ideas the SGA Legislative Policy and Research Ad Hoc Committee would promote the level of service to the Student Body by the Student Government Association; THEREFORE, BE IT RESOLVED, the Legislative Policy and Research Ad Hoc Committee shall consist of the coordinator from each Senator constituent group in addition to the Chair of each of the four SGA Internal Committees; BE IT FURTHER RESOLVED, the LPR Ad Hoc Committee shall meet at 10AM on Wednesday September 28th in the SGA Conference Room and as a first order of business select a Chair and a Secretary for the committee; BE IT FURTHER RESOLVED, the LPR Ad Hoc Committee shall be tasked with identifying common areas of need for legislative action as well as providing a direction for future legislation passed by the Senators of the Assembly; BE IT FURTHER RESOLVED, the LPR Ad Hoc Committee shall set legislative priorities and goals to be achieved by the Senators of the Assembly; BE IT FURTHER RESOLVED, the Chair of the LPR Ad Hoc Committee shall provide direction for the committee in addition to presenting a report of the recommendations and findings of the committee to the Officers of the Assembly no later than the 19th of October; BE IT FURTHER RESOLVED, the Secretary of the LPR Ad Hoc Committee shall be tasked with keeping an accurate report of the activity of the committee in addition to collaborating with the Chair to produce a final report chronicling the recommendation and findings of the committee; BE IT FURTHER RESOLVED, the LPR Ad Hoc Committee shall complete its task by the 19th of October and shall meet weekly until completion; BE IT FURTHER RESOLVED, upon reviewing the findings of the LPR Ad Hoc Committee the Officers of the Assembly may work with the Senators of the Assembly to outline a schedule and assignment of tasks to fulfill the goals laid out in the LPR Ad Hoc Committee's report; BE IT FURTHER RESOLVED, the Assembly of the Student Government Association affirms support for the Legislative Policy and Research Ad Hoc Committee;
