 4 Resolution Revising University Property Where Alcoholic Beverages are Permitted

6 WHEREAS, the Student Government Association is the official student governing body for Illinois State
 7 University;

 9 WHEREAS, the Student Government Association is an internal committee of the Academic Senate and
 10 has the ability to recommend policies, procedures or proposals to the Academic Senate for full
 11 consideration;

 13 WHEREAS, the Student Government Association is proposing a revision to policy 5.1.23 *University*
 14 *Property Where Alcoholic Beverages are Permitted* based on constituent feedback and sustaining an
 15 academic environment that both respects individual freedom and promotes the health, safety, and well
 16 being of all members of the University community.;

17
 18 WHEREAS, with the exception of the restrictions outlined in the recommended policy revision that
 19 accompanies this resolution, those who are of age shall be allowed to possess and consume in the new
 20 Cardinal Court complex;

21
 22 WHEREAS, Cardinal Court is designated for sophomores and above classes only;

23
 24 WHEREAS, numerous meetings and focus groups were held to develop a practical policy that respects
 25 individual freedom while also encouraging responsible behavior that promotes the health and well-being
 26 of the university community;

 28 WHEREAS, this language is only advisory and recommended to the Academic Senate and is subject to
 29 further discussion, deliberation, and revisions that may occur at the committee-level or from the floor of
 30 the Academic Senate;

 32 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association recommends
 33 the revised *University Property Where Alcoholic Beverages are Permitted* policy to the Academic Senate
 34 for consideration;

 36 BE IT FURTHER RESOLVED, Student Body President Owens will bring the revised policy to
 37 Academic Senate executive committee to be discussed and referred to an appropriate internal committee
 38 of the Academic Senate.
