## Resolution Revising Tobacco-Use Policy

WHEREAS, the Student Government Association is the official student governing body for Illinois State University;

WHEREAS, the Student Government Association is an internal committee of the Academic Senate and has the ability to recommend policies, procedures or proposals to the Academic Senate for full consideration:

WHEREAS, in fall 2008 SGA released a constituent feedback survey and found that over 72% of students favored further restrictions on smoking;

WHEREAS, the same survey also found that the Quad and high traffic student areas received the most complaints about second hand smoke and littering issues;

WHEREAS, in response to constituent demand, the Student Government Association placed a smoking restriction referendum on the spring student elections ballot to gauge students' opinions on the matter;

WHEREAS, the ballot passed in favor of designated smoking areas by a 2-to-1 margin, with 2/3rds of students agreeing there should be further restrictions on smoking on-campus;

WHEREAS, as stated in Article 5, Section 5, point iii, subpoint c, that "for all certified referendum results, a Senator is required to act in accordance with the majority opinion voting results of the referendum when taking Association action on the issue;"

WHEREAS, two Association-wide meetings have been held to collect feedback, input, and senator concerns on a revised tobacco-use policy;

WHEREAS, the product of such discussion is the revised tobacco-use policy that accompanies this resolution;

WHEREAS, this language is only advisory and recommended to the Academic Senate and is subject to further discussion, deliberation, and revisions that may occur at the committee-level or from the floor of the Academic Senate;

THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association recommends the revised tobacco-use policy to the Academic Senate for consideration;

BE IT FURTHER RESOLVED, Student Body President Owens will bring the revised tobacco-use policy to Academic Senate executive committee to be discussed and referred to an appropriate internal committee of the Academic Senate.
