

1 Sponsor: Student Body President Manno, Student Body Vice-President Chung, President of the 2 Assembly Adams, Secretary of the Assembly Gallagher 3 4 Resolution Authorizing SGA's Sponsorship of the IL-13 Congressional Debate 5 6 WHEREAS, the Student Covernment Association is the official student governing body for Illinois State 7 Uni versity; 8 9 WHEREAS, student outreach is a main pillar of the 2012-2013 Student Covernment Association; 10 11 WHEREAS, Illinois State University has encompassed Gvic Engagement into its core values; 12 13 WHEREAS, voter education is an aspect of civic engagement; 14 15 WHEREAS, Illinois State University will host a Congressional Debate between candidate Rodney Davis 16 and candidate David Gll in an effort to increase voter education and participation; 17 18 WHEREAS, the debate will be held in the Brown Ballroom of the Bone Student Center from 6-7: 30pm 19 20 WHEREAS, the American Democracy Project, PI Sigma Alpha, McLean County Chamber of Commerce, 21 and the League of Women Voters will be co-sponsoring the debate with the SGA; 22 23 WHEREAS, the Student Government Association will solicit questions from the student body for the 24 debate via online submissions, advertise the event through a variety of means including but not limited to 25 a press release, constituent e- mail, and use of social media, and provide a moderator for the debate; 26 27 WHEREAS, members of the Student Government Association will use their constituent contact hours for 28 the days prior to the debate in order to increase a wareness and publicize the debate to the student body; 29 30 THEREFORE, BEIT RESOLVED, the Assembly of the Student Covernment Association authorizes the 31 sponsorship of the Illinois 13th Congressional Debate 32 33 BE IT FURTHER RESOLVED, an Illinois State University Emeritus Political Science professor Bob 34 Bradley, Gties 92,9 Robert Rees, and Student Body President Andy Manno will moderate the debate: 35 36 BE IT FUTHER RESOLVED, it is mandatory for the Student Covernment Association to use their 37 constituent contact hours for the days prior to the event to properly publicize the debate; 38 39 BE IT FURTHER RESOLVED, it is mandatory for the members of the Student Government Association 40 to be in attendance; 41 42 BE IT FURTHER RESOLVED the Assenbly of the Student Government Association authorizes no 43 more than \$300 to be spent on publication tools to ensure the debates success; 44 45 BE IT FURTHER RESOLVED, the Assembly directs Secretary of Public Relations Corona to draft a 46 press release, update the social media outlets including creating a Facebook event, and work with the Vice 47 President of the Assembly to ensure the event is publicized; 48 49 BE IT FURTHER RESOLVED, the Assembly directs Student Body Executive Director Paxton to work 50 with Advisor Davenport to ensure all logistical arrangements and finances are made accordingly. 51
